GENERAL CONDITIONS

1. All the posts carry usual allowances as admissible to Central Government Employees of similar status at Gorakhpur, Uttar Pradesh.
2. **Application Process:** -The aspiring applicants satisfying the eligibility criteria in all respect can submit their application only through **Offline** mode. 3. Last date of receiving of hard copy of the completed application form in the Recruitment Cell, AIIMS, Gorakhpur is **10th June 2023**.
4. The applicants should check their eligibility for the post applied for. They must be fulfilling eligibility criteria as on the closing date of applications failing which their application will be rejected.
5. In case a candidate wishes to apply for more than one post, he/she is required to fill the form separately for each post.
6. The candidates have to send signed copy of offline application form along with self-attested copies of certificates/documents in support of fulfilling the essential criteria of age, educational qualification, teaching/research experiences etc. In support of their candidature. Retired Faculty from Institutes of National Importance (INIs) and Government Medical College (GMCs) at the level of Professor, Additional Professor and Associate Professor up to age of 70 years are eligible for applying on contract basis.
